

- Beginning in October 2023, the project is expected to be completed in March 2024.

This survey will be continued to be used at events that are specific to people experiencing unsheltered homelessness.








Unsheltered Homelessness Survey Questions


- 1. I lost my housing because of....

- 10. How long have you experienced unsheltered homelessness?







